Summary of Findings

- Capitation will be the primary form of Medicaid spending from 2017 onward. During 2016, 48.9% of national Medicaid expenditures were paid via capitation and this percentage has been increasing rapidly each year. During 2010, for example, capitation represented "only" 27% of national Medicaid spending.
- The following slides convey the extent to which each state's Medicaid expenditures were paid via capitation during 2016. The information was tabulated using CMS 64 report data. Capitation contracting figures primarily include payments to comprehensive managed care organizations (MCOs), but also include specialized capitation programs such as initiatives limited to behavioral health services and primary care case management.
- In five states Kansas, Hawaii, Arizona, Delaware and New Mexico capitation contracting represented more than 80% of the state's overall 2016 Medicaid expenditures. Kansas led the nation in this regard with 93.1% of Medicaid spending occurring via capitation payments.
- In 20 states, capitation represented the majority of 2016 Medicaid spending; nine states had no capitation contracting during 2016.
